1 Abstract / Paper Submission - General Terms

Authors who submit papers to a CIMAC Congress agree to the following general terms:

1. Only original research work is welcome. Submission of a paper to CIMAC is a declaration that it has not been published before or simultaneously submitted anywhere else.
2. The author understands that all abstract proposal and papers are peer reviewed by 2-4 independent reviewers from the Technical Program Committee and that all their comments must be addressed by making the necessary revisions.
3. The author understands that every paper submitted to a CIMAC Congress event is published only in case of acceptance by the Technical Program Committee.
4. By submitting a paper to CIMAC the author understands that its copyright is transferred to CIMAC. The author certifies that he/she has permission from every other co-author mentioned in the paper to do so.
5. It is a condition of submission of a paper that the author should edit his/her paper as many times as he/she will be requested in order to ensure the required quality and standards as well as its readability.
6. The author(s) declare(s) that there is no conflict of interests regarding the publication of their paper(s).
7. Paper withdrawals must be requested for before the review process has started.
8. All abstracts/papers must be submitted via our Electronic Paper System (EPS) in English. If you wish to send your contribution, please find the relevant details on the CIMAC Congress website and follow the instructions to upload it. We do not accept abstract proposals/papers as e-mail attachments.
9. All abstracts/papers must be written in the exact format as stated in the paper writing instructions on our website.

2 Policy

Conditions of Submission: Submission of a Paper is on the basis that the work is original and has not been published previously in the same or a similar form and is not under consideration for publication elsewhere. All co-authors must be aware of, and have consented to, the submission. Due regard must be paid to ethical considerations, and the submission must conform to the CIMAC's policy on plagiarism and paper publication ethics (see Paper Publication Ethics in following section).

Authors are required to warrant on submission that these requirements have been fulfilled and that the paper content contains no libellous or unlawful statements. Authors must approve a copyright release assignment when uploading the manuscript (see section 4. Copyright Assignment).

3 Paper Publication Ethics

Plagiarism is the copying or use of another author's work without proper acknowledgement or attribution. It is unethical and unacceptable in the context of scientific publication, infringes authors' moral rights, and may also be illegal where copyright is infringed.

Authors must ensure that all prior work on which they draw is explicitly acknowledged and that the sources are included in the list of references. This requirement relates to the methods, results, and conclusions on which the present work is built and to the text of the article in which it has been presented. If passages of text are copied word for word, the source must be given, and the text must be placed within quotation marks. If the original text is paraphrased or reproduced with minor alterations, this must be made clear and the source given. It is unacceptable to reproduce extensive passages of text and/or figures and tables without permission from the author(s) and the copyright holder.

A related unacceptable practice is “redundant publication,” which is the multiple publication or submission by an author of the same research or the reuse of substantial portions of articles (including figures and tables) without acknowledgement of prior publication. This includes publication of a paper in different languages. Redundant publication of the same material and plagiarism of others' work without acknowledgement are serious ethical offenses that may leave the author open to sanction.

It is the responsibility of lead authors and the organizations/institutions in which they work to ensure that papers appearing under their names conform to these guidelines. It is a condition of submission to the CIMAC Congress that all authors of any paper found, following due process, to breach good practice accept responsibility for this breach, which will be subject to sanction at CIMAC's absolute discretion. These sanctions may include, inter alia, the retraction of a published paper, publication of a note of correction or apology, banning of future submissions and/or participation by the organization/institution for a specified period, and/or notification of the head of the authors' department or organization.

4 Copyright Assignment

It is a condition of publication that, on acceptance of the paper by CIMAC, copyright of the entire manuscript has been assigned to CIMAC. This is done at the time of registration to the Electronic Paper System (EPS) for abstract & paper submissions when the Author accepts the 'Terms & Copyright Assignment' through this document. If the author is not able to make the assignment, the author's employer may sign the copyright agreement. However, after a paper has been published at the respective CIMAC Congress, CIMAC is pleased to let the authors republish the paper elsewhere. The authors will have to acquire prior permissions for this from CIMAC by agreeing to provide due acknowledgements to CIMAC, and by stating that the copyright of the paper/content remains with CIMAC.
